

## RESOLUTION NO. 85

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred peses (\$\preceite{3}00.00), or so much thereof as may be necessary, is hereby reverted from out of the unexpended balance on travel and transportation of the Municipal Board, said sum to be made available as supplemental appropriation for contribution to the the fund drive for community projects and Fourth Induction Ceremonies of the Rotary Club of Ormoc.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
