"RESOLVED, to adopt:

ORDINANCE NO. 49

AN ORDINANCE APPROPRIATING TWENTY PESOS (P20.00) FOR OUTSTANDING OBLIGATIONS COVERING TERMINAL LEAVE OF EX-PATROLMAN BIBIANO CAUBAT OF THE ORMOC CITY POLICE DEPARTMENT, AS AUTHORIZED BY THE CITY AUDITOR.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of twenty pesos (P20.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for outstanding obligations covering the terminal leave of Ex-Patrolman Bibiano Caubat of the Ormoc City Police Department for the period from April 1 to 4, 1967, inclusive, as authorized by the City Auditor.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
