RESOLUTION NO. 9

"WHEREAS, the Deputy Chief of Police in a letter dated January 12, 1970, has informed that as of November 30, 1969, an overdraft has been incurred in the item for subsistence of prisoners in the sum of ₱474.35 and, considering that the monthly average for this item is ₱1,300.00, has requested a supplemental appropriation of ₱9,000.00 for the same item covering up to June 30, 1970;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Samson;

"RESOLVED, to approve the request of the Deputy Chief of Police and do, as this Body hereby does, adopt:

ORDINANCE NO. 5

AN ORDINANCE REVERTING THE SUM OF NINE THOUSAND PESOS (₱9,000.00) FROM OUT OF SAVINGS IN (C-15) POLICE DEPARTMENT TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR SUBSISTENCE OF CITY PRISONERS UP TO JUNE 30, 1970.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of nine thousand pesos (₱9,000.00), or so much thereof as may be necessary, is hereby reverted from out of savings in (C-15) Police Department, 1969-1970 Ormoc City Budget, said sum to be made available for supplemental appropriation for subsistence of city prisoners up to June 30, 1970.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, January 21, 1970.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Deputy Chief of Police, the City Treasurer and the City Auditor, all of Ormoc City;
