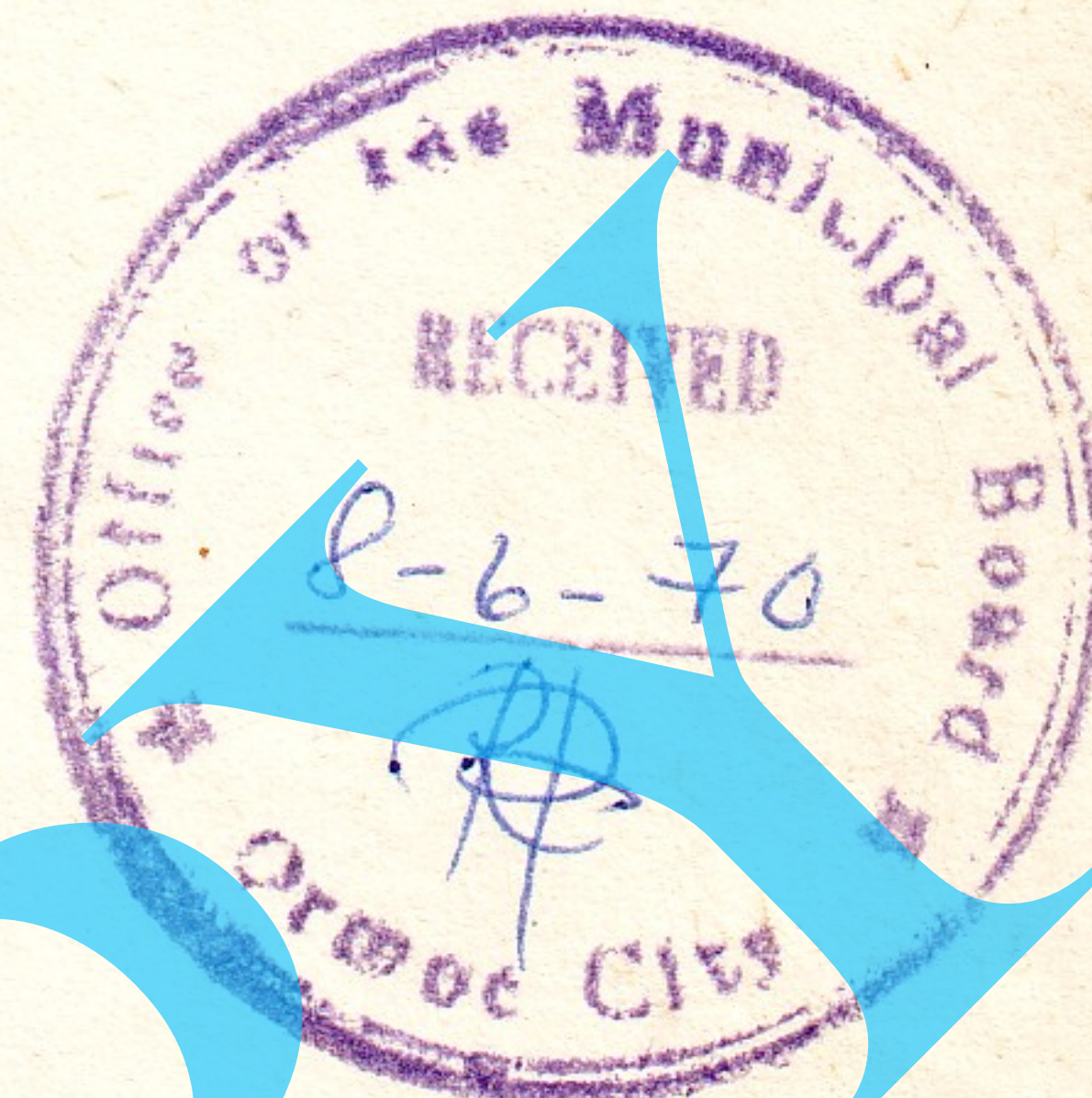

RESOLUTION NO. 97

"WHEREAS, the Serafica Caltex Service Station has presented a voucher in the sum of six hundred fifty-three pesos and ninety-seven centavos (P653.97) for gasoline, oil, grease and some spare parts purchased on account for use in the Mayor's car assigned to the Municipal Board which have not been paid up to the closing of the account books of the city so that this becomes an outstanding obligation to the said service station;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 51

AN ORDINANCE APPROPRIATING THE SUM OF SIX HUNDRED FIFTY-THREE PESOS AND NINETY-SEVEN CENTAVOS OUT OF FUNDS NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE FOR PAYMENT OF OUTSTANDING OBLIGATIONS TO THE SERAFICA CALTEX SERVICE STATION FOR GASOLINE, OIL, GREASE AND SOME SPARE PARTS FOR THE MAYOR'S CAR ASSIGNED TO THE MUNICIPAL BOARD.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of six hundred fifty-three pesos and ninety-seven centavos (P653.97), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for payment of outstanding obligations to the Serafica Caltex Service Station for gasoline, oil, grease and some spare parts for the Mayor's car assigned to the Municipal Board.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
