## ORDINANCE NO. 52

AN ORDINANCE APPROPRIATING THE SUM OF NINE HUNDRED FIFTY PESOS (P950) TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR CERTAIN ITEMS UNDER CONTINGENT EXPENSES OF THE CITY COURT

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of nine hundred fifty pesos (P950.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury, said sum to be made available as supplemental appropriation for the following items under Contingent Expenses of the City Court:
