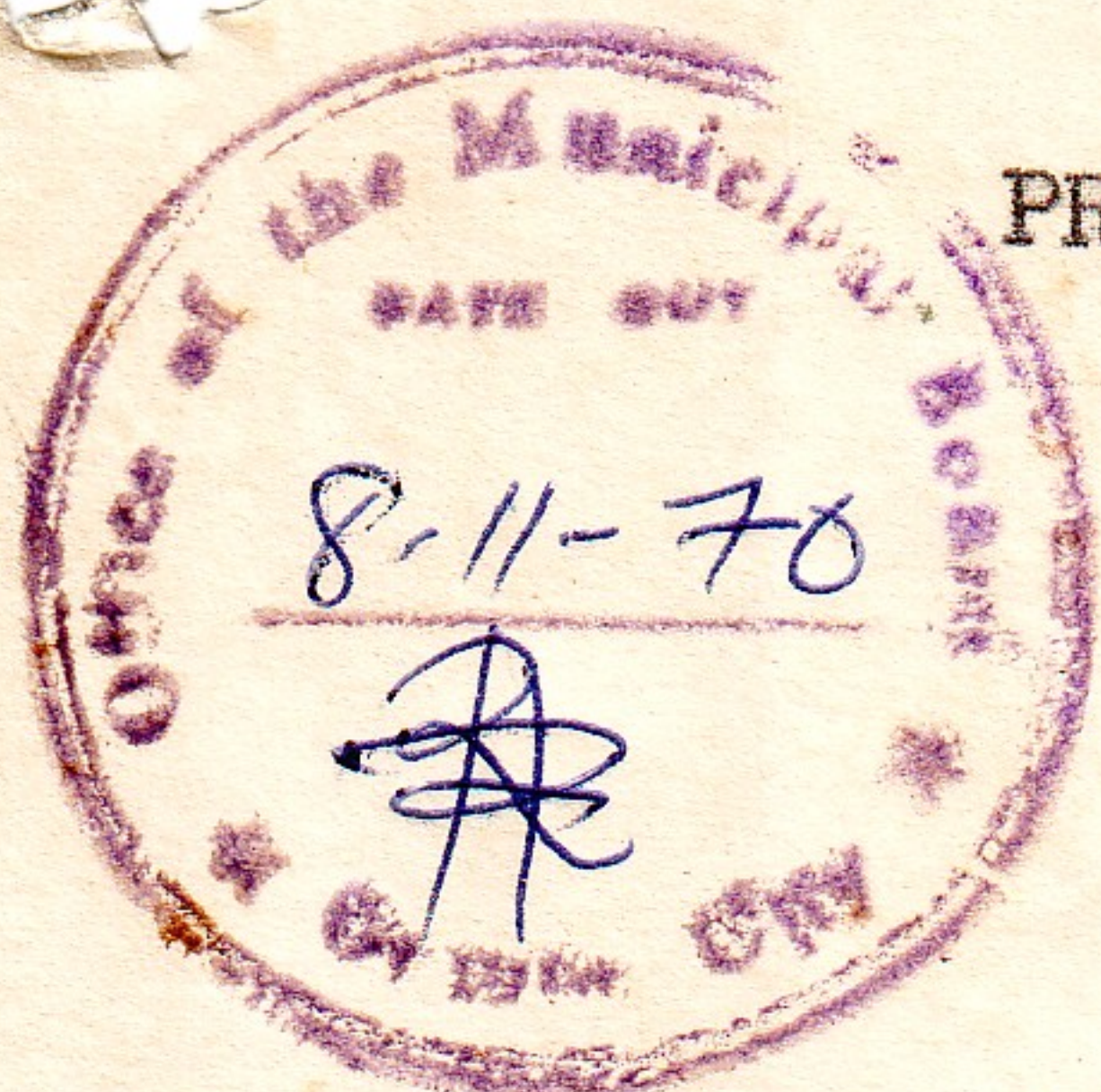

RESOLUTION NO. 104

"WHEREAS, the Officer in Charge, Office of the City Treasurer, has reported that our appropriation for the purchase of the heavy-duty hanging scale was lacking by ₱567.00 and that he had caused the construction of a cage for the protection of the scale which also amounted to almost ₱200.00 so that he has requested an appropriation of at least ₱700.00 more for this purpose;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded by Councilor Aviles;

"RESOLVED, to adopt:

ORDINANCE NO. 53

AN ORDINANCE REVERTING THE SUM OF SEVEN HUNDRED PESOS (₱700.00) FROM OUT OF ANY SAVINGS TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR ADDITIONAL COST OF THE HEAVY-DUTY HANGING SCALE AND CONSTRUCTION OF ITS PROTECTIVE CAGE IN THE PUBLIC MARKET.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of seven hundred pesos (₱700.00), or so much thereof as may be necessary, is hereby reverted from out of any savings of the City, said sum to be made available as supplemental appropriation for additional cost of the heavy-duty hanging scale and construction of its protective cage in the public market;

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, August 5, 1970.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Treasurer, the City Auditor, the Market Administrator, and the Property Clerk, all of Ormoc City;
