RESOLUTION NO. 106

"WHEREAS, the City Fiscal in his letter dated August 11, 1970, has requested the reversion of the amount of ₱235.00 from out of the item on repair of office equipment in his department which he would like to be made available for the purchase of an office table and a chair for the Special Counsel;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Porcadilla;

"RESOLVED, to approve the request of the City Fiscal and do, as this Body hereby does, adopt:

ORDINANCE NO. 54

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED THIRTY-FIVE PESOS (₱235.00) FROM OUT OF ITEM ON REPAIR OF OFFICE EQUIPMENT IN THE LAW DEPARTMENT TO BE MADE AVAILABLE FOR THE PURCHASE OF AN OFFICE TABLE AND A CHAIR FOR THE SPECIAL COUNSEL.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred thirty-five pesos (₱235.00), or so much thereof as may be necessary, is hereby reverted from out of the item on repair of office equipment in the Law Department, said sum to be made available as supplemental appropriation for the purchase of an office table and a chair for the Special Counsel.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
