RESOLUTION NO. 112

"WHEREAS, the Deputy Chief of Police in a communication dated 17 August 1970 has requested the reversion of P800.00 from out of salary savings in his department to be made available for the hospitalization, medicines, subsistence and other expenses of Patrolman Urbano Arradaza who was injured while in line of duty and is still confined in the Ormoc General Hospital;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded jointly by Councilors Aviles and Samson;

"RESOLVED, to approve the request of the Deputy Chief of Police and do, as this Body hereby does, adopt:

ORDINANCE NO. 57

AN ORDINANCE REVERTING THE SUM OF EIGHT HUNDRED PESOS (P800.00) FROM OUT OF SALARY SAVINGS IN THE POLICE DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE HOSPITALIZATION AND OTHER EXPENSES OF PATROLMAN URBANO ARRADAZA.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of eight hundred pesos (P800.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Police Department, said sum to be made available as supplemental appropriation for the hospitalization, medicines, subsistence and other expenses of Patrolman Urbano Arradaza now confined in the Ormoc General Hospital.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
