"RESOLVED, to adopt:

ORDINANCE NO. 58

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 16, SERIES OF 1948, PARTICULARLY, THE SLAUGHTER FEE FOR CARABAO OR BUFFALO, UNDER SECTION TWO THEREOF, TO TWENTY PESOS (P20.00) PER HEAD.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Amendment. - Ordinance No. 16, series of 1948, as amended by Ordinance No. 6, series of 1968, particularly the slaughter fee for carabao or buffalo, under Section 2 thereof, is hereby amended further to read as follows:

"Carabao or buffalo P20.00 per head"

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
