RESOLUTION NO. 10

"WHEREAS, the Supervising Management Analyst I and In Charge, Office of the City Treasurer, in a communication dated January 20, 1970, has requested an authority to charge ₱1,200.00 against current appropriations for building rentals of the Municipal Board inasmuch as this amount, due to oversight, was paid to Mrs. Ramona C. Pongos for back rentals of her building used formerly by the Municipal Board which should have been applicable to fiscal year 1968-1970 but was not taken up by his office as an outstanding obligation;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Samson;

"RESOLVED, to authorize the City Treasurer to charge ₱1,200.00 against current appropriation for building rentals of the Municipal Board and do, as this Body hereby does, adopt:

ORDINANCE NO. 6

AN ORDINANCE REVERTING THE SUM OF ONE THOUSAND TWO HUNDRED PESOS (₱1,200) FROM OUT OF THE ITEM ON DBP LOAN AMORTIZATION OF (C-36) MARKET AND SLAUGHTERHOUSE TO BE MADE AVAILABLE FOR SUPPLEMENTAL APPROPRIATION FOR BUILDING RENTALS OF THE MUNICIPAL BOARD.

BUT IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand two hundred pesos (₱1,200.00), or so much thereof as may be necessary, is hereby reverted from out of the item on DBP loan amortization of (C-36) Market and Slaughterhouse, 1969-1970 Ormoc City Budget, said sum to be made available for supplemental appropriation for building rentals of the Municipal Board.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
