RESOLUTION NO. 121

"WHEREAS, the Division Academic Supervisor for City Schools, this City, in a communication of September 3, 1970, has requested an appropriation of ₱200.00 for the purchase of 10 sheets of marine plywood, some nails and 10 meters of cloth for the improvement and repair of the office taking charge of city schools, such as replacing the retting ceiling and providing its window with curtains to control the glaze and heat of the afternoon sun;

"WHEREAS, this august Body finds the request of the Academic Supervisor noteworthy considering that it will redound to the greater efficiency of the office;

"NOW, THEREFORE, on motion of Councilor Tan, seconded by Councilor Samson;

"RESOLVED, to approve the request of the Academic Supervisor, Division of City Schools, and do, as this Body hereby does, adopt:

ORDINANCE NO. 60

AN ORDINANCE APPROPRIATING THE SUM OF TWO HUNDRED PESOS (₱200.00) FOR AID TO THE DIVISION OF CITY SCHOOLS IN THE REPAIR AND IMPROVEMENT OF ITS OFFICE.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred pesos (₱200.00), or so much thereof as may be necessary, is hereby appropriated out of funds not otherwise appropriated in the City Treasury, said sum to be made available as supplemental appropriation for aid to the Division of City Schools, Ormoc City, in the repair and improvement of its office.

SECTION 2. This Ordinance shall take effect immediately upon its approval.

ENACTED, September 9, 1970.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Academic Supervisor, Division of City Schools, the City Auditor and the City Treasurer, all of Ormoc City;
