ORDINANCE NO. 62

AN ORDINANCE REVERTING THE SUM OF SIX HUNDRED SIXTEEN PESOS AND TWEN-TY-SIX CENTAVOS (P616.26) FROM OUT OF SALARY SAVINGS IN THE AGRI-CULTURAL AND VETERINARY EXTENSION SERVICES TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR INSURANCE REFILIMS ON CERTAIN GOVERNMENT BUILDINGS AND/OR PROPERTIES. AS REQUESTED BY THE CITY TREASURER.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of six hundred sixteen pesos and twenty-six centaves (\$\frac{1}{26}.26), or so much thereof as may be necessary, is hereby reverted from out of salary savings in the Agricultural and Veterinary Extension Services, said sum to be made available as supplemental appropriation for insurance premiums on the city hall building, market tiendas, slaughterhouse and other city government properties, as requested by the City Treasurer.
