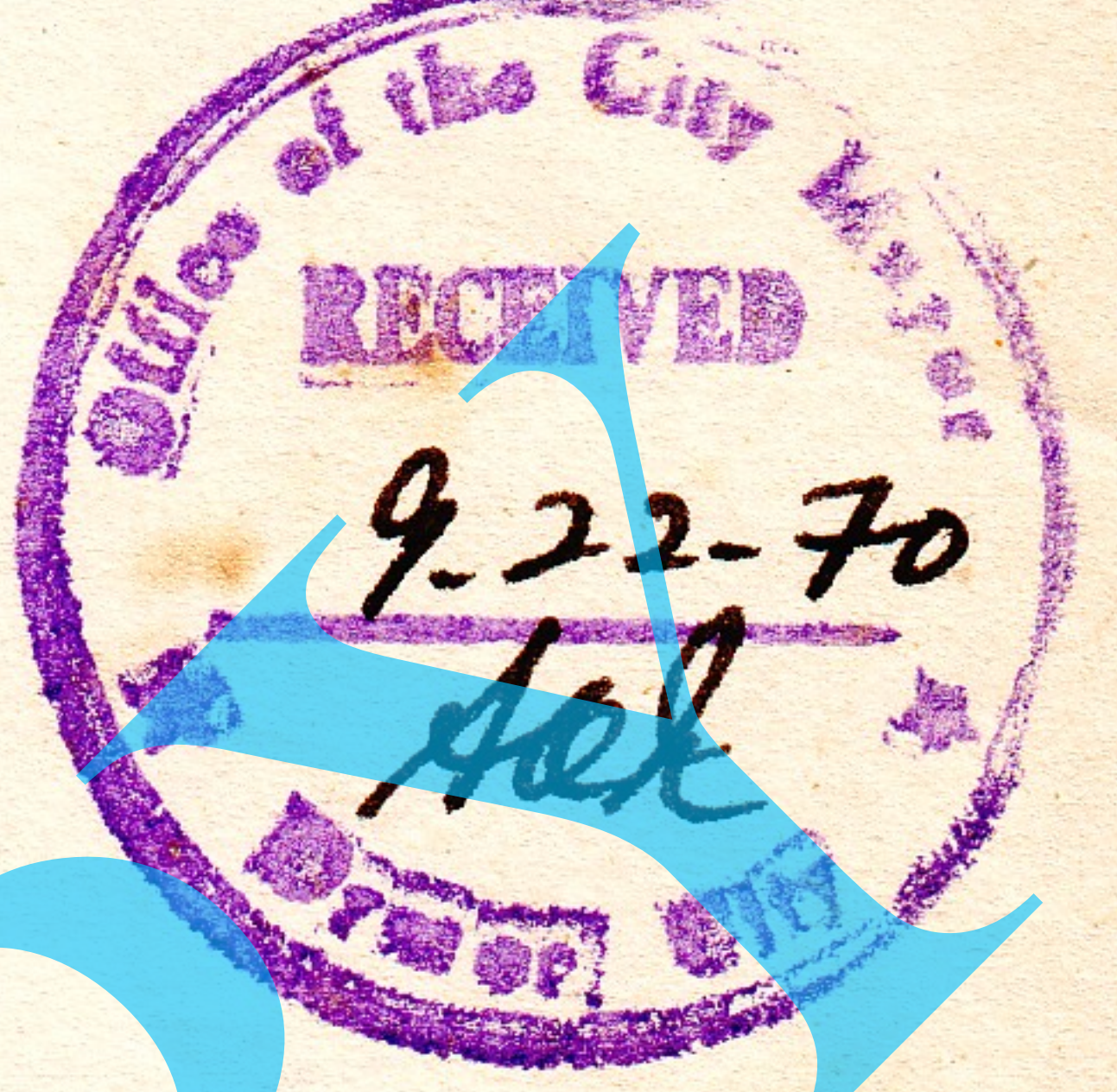
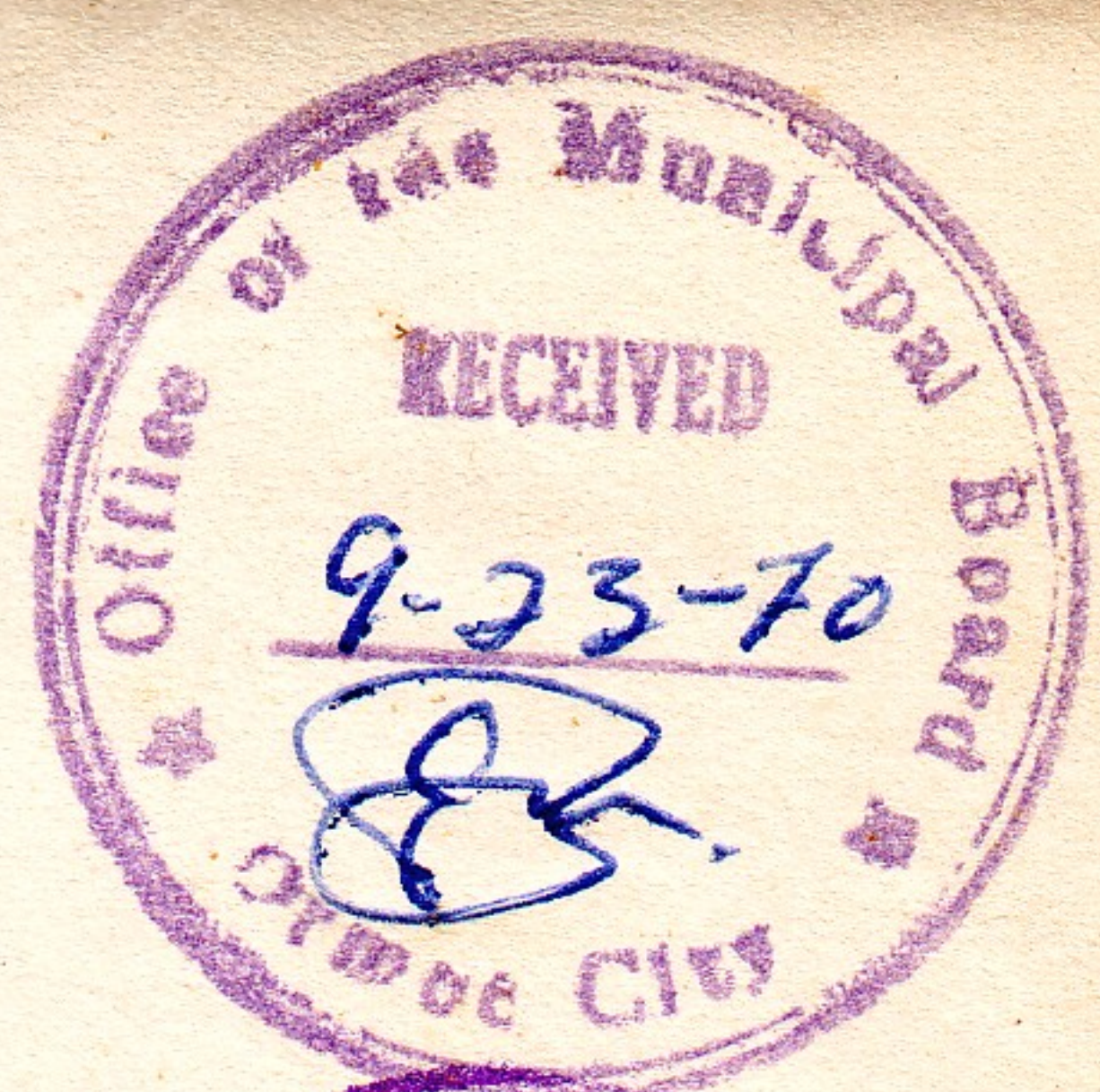
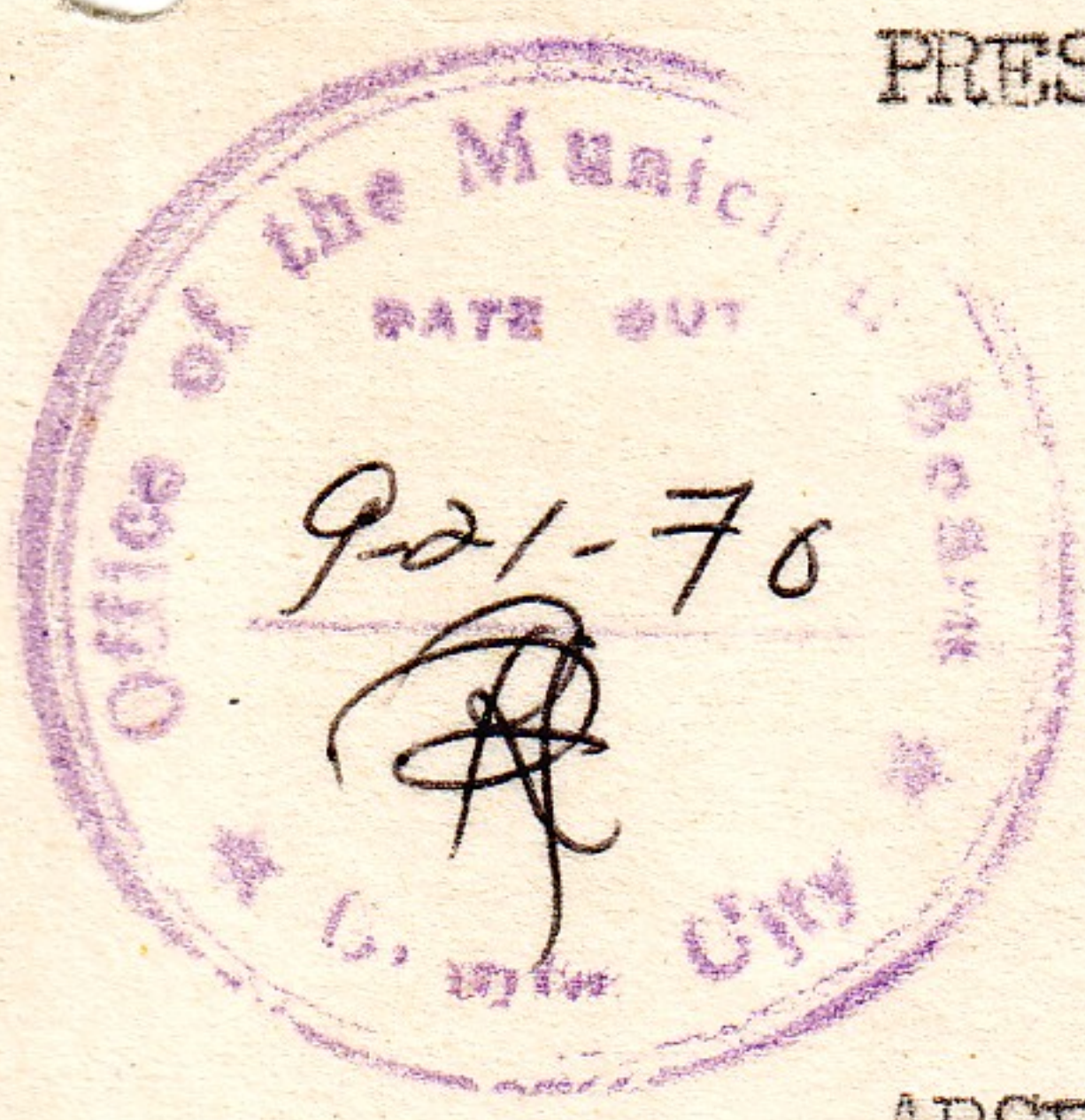

ORDINANCE NO. 66

AN ORDINANCE AMENDING ITEM NO. 5 OF (C-2) MUNICIPAL BOARD, UNDER SECTION 2 OF ORDINANCE NO. 48, CURRENT SERIES, OTHERWISE KNOWN AS "THE 1970-1971 ORMOC CITY BUDGET".

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Item No. 5 of (C-2) Municipal Board, under Section 2 of Ordinance No. 48, current series, otherwise known as "The 1970-1971 Ormoc City Budget", is hereby amended to read as follows:
