ORDINANCE NO. 69

AN ORDINANCE REVERTING THE SUM OF TWO HUNDRED FIFTY-TWO PESOS (P252.00) FROM OUT OF SALARY SAVINGS OF THE POLICE DEPARTMENT TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR TRAVEL AND TRANSPORTATION OF SGT. FRANCISCO COVERO AND PAT. SORIANO MATA ON SPECIAL MISSION TO CEBU CITY.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of two hundred fifty-two pesos (P252.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of the Police Department, said sum to be made available as supplemental appropriation for travel and transportation of two members thereof on mission to Cebu City in the manner provided hereunder as follows:
