ORDINANCE NO. 7

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED TWENTY-FIVE PESOS
(P525.00) FROM OUT OF SAVINGS IN (C-25a) AGRICULTURAL EXTEN-
SION SERVICE TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRI-
ATION FOR AID TO THE COURT OF FIRST INSTANCE, COURT OF AGRA-
RIAN RELATIONS, AND OFFICE OF THE REGISTER OF DEEDS, FOR
PAYMENT OF THEIR OUTSTANDING OBLIGATIONS TO THE GOVERNMENT
TELEPHONE SERVICE, BUREAU OF TELECOMMUNICATIONS, ORMOC CITY.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of five hundred twenty-five pesos (P525.00),
or so much thereof as may be necessary, is hereby reverted from out
of savings in (C-25a) Agricultural Extension Service, 1969-1970 Ormoc
City Budget, said sum to be made available as supplemental appropria-
tion for aid to the Court of First Instance, Court of Agrarian Rela-
tions, and Office of the Register of Deeds for payment of their out-
standing obligations to the Government Telephone Service, Bureau of
Telecommunications, Ormoc City, in the manner provided hereunder as
follows:

a. Court of First Instance, January to August, 1969 ...	P160.00
b. Court of Agrarian Relations,	
January to August, 1969 ...	160.00
c. Office of the Register of Deeds,	
September to December, 1968 ...	P 85.00
January to June, 1969	120.00 ... 205.00
Total	P525.00

SECTION 2. This Ordinance shall take effect immediately upon its
approval.
