ORDINANCE NO.

AN ORDINANCE REVERTING THE SUM OF FIVE HUNDRED TWENTY-FIVE PESOS (\$525.00) FROM OUT OF SAVINGS IN (C-25a) AGRICULTURAL EXTEN-SION SERVICE TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR ALL TO THE COURT OF FIRST INSTANCE, COURT OF AGRA-RIAN CRIATIONS, AND OFFICE OF THE REGISTER OF DEEDS, FOR PAYMENT OF THEIR OUTSTANDING OBLIGATIONS TO THE GOVERNMENT TELEPHONA SERVICE, BUREAU OF TELECOMMUNICATIONS, ORMOC CITY.
