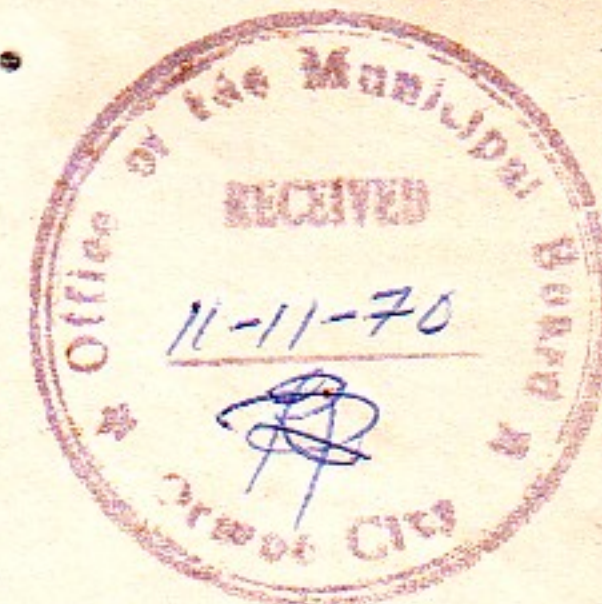

RESOLUTION NO. 164

"WHEREAS, this august Body urgently needs the services of a liaison officer for all intents and purposes in line with the program of the City Administration;

"NOW, THEREFORE, on motion of Councilor Tan, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 73

AN ORDINANCE CREATING THE POSITION OF LIAISON OFFICER OF THE MUNICIPAL BOARD WITH COMPENSATION AT THE RATE OF TWO THOUSAND EIGHT HUNDRED EIGHTY PESOS (P2,880.00) PER ANNUM, PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The position of Liaison Officer of the Municipal Board is hereby created with compensation at the rate of two thousand eight hundred eighty pesos (P2,880.00) per annum to be taken from out of salary savings in the Ormoc City High School following the abolition of the item on provisional teacher: Provided, That, funds for this purpose shall be provided for in subsequent general appropriations.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
