"RESOLVED, to adopt:

**ORDINANCE NO. 74**

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 11, SERIES OF 1970, ENTITLED, "AN ORDINANCE TO LEVY MUNICIPAL, CAPITAL OR GROSS SALES TAXES OF ONE PERCENT (1%) ON THE SALE OF MERCHANDISE AND TWO PERCENT (2%) ON THE SALE OF HARDWARE AND AUTO SUPPLY IN THE CITY OF ORMOC AND FOR OTHER PURPOSES."

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Section 1 of Ordinance No. 11, series of 1970, is hereby amended to read as follows:

"SECTION 1. Municipal tax. - There shall be paid to the City Treasurer by any person, partnership, firm, association, corporation or entity engaged in business or the like in the City of Ormoc municipal, capital or gross sales taxes of one percent (1%) on the sale of merchandise and two percent (2%) on the sale of hardware and auto supply every month, excepting liquor or intoxicating beverages and soft drinks of any form sold by manufacturers and/or wholesalers of the same."

SECTION 2. This Ordinance shall take effect immediately upon its approval.
