ORDINANCE NO. 75

AN ORDINANCE AMENDING ITEM NO. 7 OF AIDS AND TRANSFER OF FUNDS UNDER SECTION 2 OF ORDINANCE NO. 48, SERIES OF 1970, OTHERWISE KNOWN AS THE "1970-1971 ORMOC CITY BUDGET".

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Item No. 7 of Aids and Transfer of Funds under Section 2 of Ordinance No. 48, series of 1970, otherwise known as the "1970-1971 Ormoc City Budget", is hereby amended to read as follows:

"7 : New Aid to Court of First Instance - for travel allowance of the Judge ₱1,200.00"

SECTION 2. This Ordinance shall take effect immediately upon its approval.
