"RESOLVED, to adopt:

ORDINANCE NO. 76 AN ORDINANCE ABOLISHING THE NEW POSITION OF TECHNICAL ASSISTANT (ITEM NO. 6) AND CREATING A NEW POSITION OF LABORER, BOTH IN THE OFFICE OF THE CITY MAYOR, PROVIDING FUNDS FOR COMPENSATION OF THE LATTER AT THE RATE OF TWO THOUSAND ONE HUNDRED SIXTY PESOS (\$2,160,00)

PER ANNUM

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The new position of Technical Assistant (Item No. 6) in the Office of the City Mayor is hereby abolished.

SECTION 2. A new position of Laborer is hereby created in the Office of the City Mayor with compensation at the rate of two thousand one hundred sixty pesos (\$2,160,00) per annum to be taken from out of salary savings in the same department: Provided, However, that funds for this purpose shall be provided in subsequent general appropriation ordinances.

SECTION 3. This Ordinance shall take effect as of December 1, 1970.
