RESOLUTION NO. 179

"The Board, on motion of Councilor Samson, seconded by Councilor Tan;

"RESOLVED, to adopt:

ORDINANCE NO. 76

AN ORDINANCE ABOLISHING THE NEW POSITION OF TECHNICAL ASSISTANT (ITEM NO. 6) AND CREATING A NEW POSITION OF LABORER, BOTH IN THE OFFICE OF THE CITY MAYOR, PROVIDING FUNDS FOR COMPENSATION OF THE LATTER AT THE RATE OF TWO THOUSAND ONE HUNDRED SIXTY PESOS (P2,160.00) PER ANNUM.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The new position of Technical Assistant (Item No. 6) in the Office of the City Mayor is hereby abolished.

SECTION 2. A new position of Laborer is hereby created in the Office of the City Mayor with compensation at the rate of two thousand one hundred sixty pesos (P2,160.00) per annum to be taken from out of salary savings in the same department: Provided, However, that funds for this purpose shall be provided in subsequent general appropriation ordinances.

SECTION 3. This Ordinance shall take effect as of December 1, 1970.

ENACTED, December 9, 1970.
