ORDINANCE

AN ORDINANCE REVERTING THE SUM OF NINETY-FIVE POSOS (\$95.00) FROM OUT OF SALARY SAVINGS IN (C-17) HEALTH DEPARTMENT TO BE MADE OVAILABLE AS SUPPLIMENTAL APPROPRIATION FOR OUTSTANDING OBLIGATION TO MR. JUANTTO CARITON, MARKET CLEANER, FOR PAYMENT OF SALARY DESCRIPTION FROM THE CONTROL OF SALARY DESCRIPTION FROM THE CO OF SALARY DEFERENCE FROM \$150.00 TO \$170.00 PER MONTH FOR THE PERIOD FROM FEBRUARY 1 TO JUNE 30, 1968, INCLUSIVE.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of ninety-five pesos (\$95.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-17) Health Department, 1969-1970 Ormoc City Budget, said sum to be made available as supplemental appropriation for outstanding obligation to Mr. Juanito Dapiton, Market Cleaner, for payment of salary difference from \$150.00 to \$17.0.00 per month for the period from February 1 to June 30, 1968, inclusive.
