"RESOLVED, to adopt:

ORDINANCE NO. 9

AN ORDINANCE AMENDING ORDINANCE NO. V, SERIES OF 1954

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Title. - The title of Ordinance No. V, series of 1954, is hereby amended to read as follows:

"AN ORDINANCE IMPOSING INSPECTION FEES AND LIMITATIONS ON HOGS, CATTLE, CARABAOS AND OTHER WORK ANIMALS TO BE SHIPPED AND/OR TRANSPORTED OUT OF ORMOC CITY, PROVIDING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES."

SECTION 2. Inspection fees and limitations. - Henceforth, the following inspection fees shall be imposed on hogs, cattle, carabaos and other work animals to be shipped and/or transported out of Ormoc City:

- a. Hogs ₱0.50 per head
- b. Cattle or carabaos and other
work animals 2.00 per head

after said livestock are inspected by proper authorities for contagious animal diseases or pests: PROVIDED, HOWEVER, That not more than thirty (30) heads of hogs and not more than ten (10) heads of cattle or carabaos and other work animals shall be transported by every licensed shipper per shipment.

SECTION 3. Penalty for violation. - Any violation of the provisions of this Ordinance shall be punishable by a fine of not less than one hundred pesos (₱100.00) but not more than two hundred pesos (₱200.00) or an imprisonment of not less than ten (10) days but not more than twenty (20) days, or both such fine and imprisonment at the discretion of the court, and permanent revocation of license.

SECTION 4. Effectivity. - This Ordinance shall take effect immediately upon its approval.






