"RESOLVED, to adopt:

ORDINANCE NO. 1

AN ORDINANCE AMENDING ORDINANCE NO. 44, SERIES OF 1970,  
SO AS TO INCLUDE A PROVISION FOR PURCHASE OF SUP-  
PLIES AND EQUIPMENT FOR THE HEALTH DEPARTMENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Amendment. - Section 1 of Ordinance No. 44, series of 1970, is hereby amended to read as follows:

"SECTION 1. The sum of two thousand three hundred eighty-three pesos and seventy-eight centavos (P2,383.78), or so much thereof as may be necessary, is hereby appropriated from out of the shares of Ormoc City from the Philippine Charity Sweepstakes draws, said sum to be made available as supplemental appropriation for the improvement of health centers in the City of Ormoc and purchase of medicines, supplies and equipment for the Health Department."

SECTION 2. This Ordinance shall take effect immediately upon its approval.
