RESOLUTION NO. 111

"WHEREAS, the Barrio Councils of Barrios Alegria and Batuan, Ormoc City, in joint Resolution No. 1 dated August 3, 1971, have requested that the name of 'Alegria Community School' be changed to 'Alegria-Batuan Community School' because, although this elementary institution of learning bears the official name of 'Alegria Community School' as per records on file with the Bureau of Public Schools, the Division of Leyte III, and the Division of City Schools, of Ormoc City, nevertheless, it has been a recipient of aids from Barrio Batuan, not to mention the support and maintenance of said barrio for its normal and smooth operations so that in fairness and justice to the people of Barrio Batuan and in order to safeguard the barrio officials concerned against illegal disbursement of government funds in favor of the school, it has become imperative to change its present name to 'Alegria-Batuan Community School';

"WHEREAS, to top it all, Alegria Community School is so situated within the territory of Barrio Batuan that it should have borne the name of 'Batuan Community School';

"WHEREAS, this august Body finds joint Resolution No. 1, current series, of the Barrio Councils of Barrios Alegria and Batuan, Ormoc City, most worthy of our consideration taking into account the fact that the children going to the Alegria Community School are mostly residing in the barrios of Alegria and Batuan;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Kangleon;

"RESOLVED, to approve Resolution No. 1, current series, jointly passed by the Barrio Councils of Barrios Alegria and Batuan, Ormoc City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 10

AN ORDINANCE RENAMING ALEGRIA COMMUNITY SCHOOL  
IN BARRIO BATUAN, ORMOC CITY, "ALEGRIA-  
BATUAN COMMUNITY SCHOOL".

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. Alegria Community School in Barrio Batuan,  
Ormoc City, is hereby renamed "Alegria-Batuan Community  
School".


SECTION 2. This Ordinance shall take effect immediate-


"RESOLVED, FURTHER, to furnish a copy of this reso-




