ORDINANCE NO. 11

AN ORDINANCE APPROPRIATING THE SUM OF ONE HUNDRED TWENTY-FIVE PESOS (\$125.00) OUT OF FUNDS NOT OTHERWISE APPRO-PRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIA-TION FOR PAYMENT OF JOB ORDER IN CONNECTION WITH THE GATE CONSTRUCTION FOR THE COMPOUND ENCLOSING THE OFFICES OF THE MUNICIPAL BOARD AND THE AGRICULTURAL AND VETERI-NARY EXTENSION SERVICES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one hundred twenty-five pesos (P125,00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for payment of job order in connection with the gate construction for the compound enclosing the offices of the Municipal Board and the Agricultural and Veterinary Extension Services.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
