

ORDINANCE NO. 13

AN ORDINANCE AMENDING ITEM NO. 20 UNDER (C-35) WATERWORKS SYSTEM, SECTION 2 OF ORDINANCE NO. 5, CURRENT SERIES, OTHERWISE KNOWN AS THE "1971-1972 ORMOC CITY BUDGET".

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Amendment. - Item No. 20 of (C-35) Waterworks System, under Section 2 of Ordinance No. 5, current series, otherwise known as the "1971-1972 Ormoc City Budget", is hereby amended to read as follows:

"20 : 20 Repair of equipment and motor vehicle and purchase of one (1) bicycle and one (1) jeep trailer P4,000.00"

SECTION 2. This Ordinance shall take effect immediately upon its approval.
