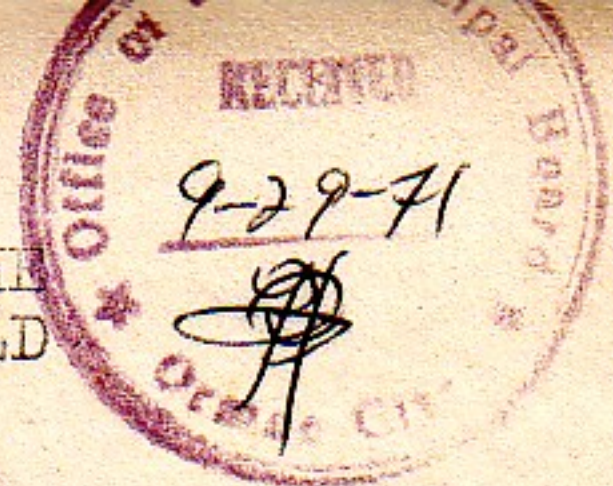

RESOLUTION NO. 149

"WHEREAS, the Barrio Council of Barrio San Juan in Resolution No. 7, current series, has requested an appropriation for the construction of a reservoir and/or aqueduct in the sum of one thousand five hundred pesos (P1,500.00) in order to alleviate the condition prevailing among the barrio people who have been buying this prime necessity from water tenders at the rate of thirty centavos per can, while those who cannot afford comprising the great majority of the barrio residents have to fetch water for themselves from the spring situated in Sitio Maigang;

"WHEREAS, this august Body finds the request of the Barrio Council of Barrio San Juan most worthy of our consideration taking into account the tremendous benefit to be derived from the construction of a reservoir and/or aqueduct availing in this connection the source of potable water in the spring of Sitio Maigang;

"NOW, THEREFORE, on motion of Councilor Torre Villas, seconded jointly by all the other Councilors;

"RESOLVED, to approve Resolution No. 7, current series, of the Barrio Council of Barrio San Juan, Ormoc City, and do, as this Body hereby does, adopt:

ORDINANCE NO. 14

AN ORDINANCE APPROPRIATING THE SUM OF ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) OUT OF FUNDS EXISTING IN THE CITY TREASURY NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR THE CONSTRUCTION OF A RESERVOIR AND/OR AQUEDUCT IN BARRIO SAN JUAN

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

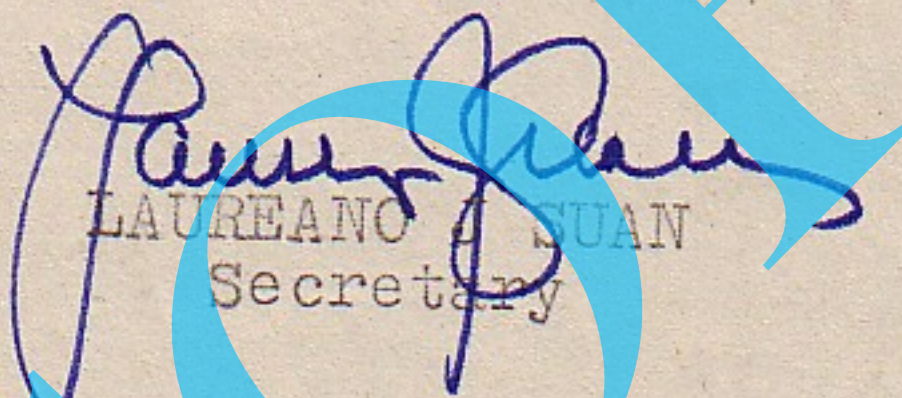
SECTION 1. The sum of one thousand five hundred pesos (P1,500.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for the construction of a reservoir and/or aqueduct in Barrio San Juan, Ormoc City;

SECTION 2. This Ordinance shall take effect immediately upon its approval.

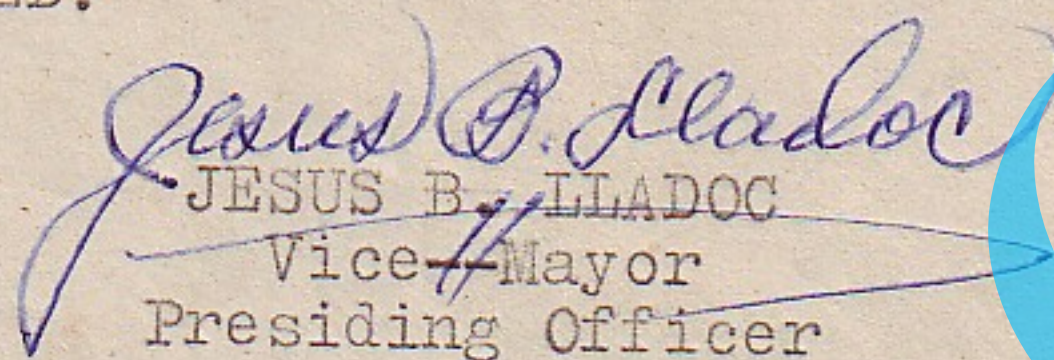

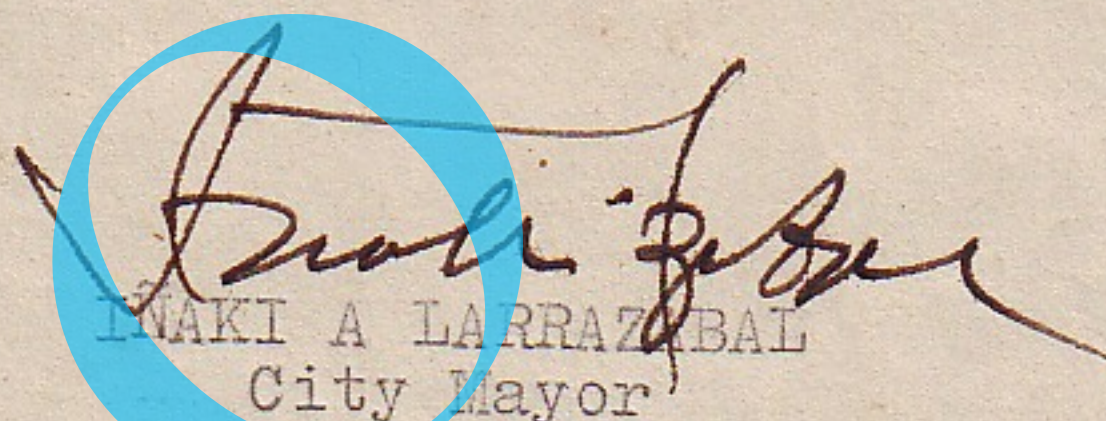
