ORDINANCE NO. 16

AN ORDINANCE AMENDING ORDINANCE NO. 10, SERIES
OF 1969, OTHERWISE KNOWN AS THE MARKET AND
SLAUGHTERHOUSE CODE OF ORMOC CITY.

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Ordinance No. 10, series of 1969, otherwise
known as the Market and Slaughterhouse Code of Ormoc City,
is hereby amended by inserting a new section between Sec-
tions five and six, to be known as Section Five-A and shall
read as follows:

"SECTION 5-a. The sanitary maintenance and
inspection of markets and slaughterhouses shall
be under the direct supervision and control of
the City Health Officer."

SECTION 2. This Ordinance shall take effect immediate-
ly upon its approval.
