ORDINANCE NO. 17

AN ORDINANCE AMENDING ITEM NO. 18 OF (C-17) HEALTH DEPARTMENT, UNDER SECTION 2 OF ORDINANCE NO. 5, SERIES OF 1971, OTHERWISE KNOWN AS "THE 1971-1972 ORMOC CITY BUDGET".

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Item No. 18 of (C-17) Health Department, under Section 2 of Ordinance No. 5, series of 1971, otherwise known as "The 1971-1972 Ormoc City Budget", is hereby amended to read as follows:
