RESOLUTION NO. 195

"WHEREAS, the City Assessor, City Auditor, City Fiscal, City Engineer and City Treasurer in a joint communication of December 21, 1971, have requested an increase of their monthly representation allowances as allowed by Memorandum Circular No. 128, dated December 15, 1967, of the Office of the President, for various reasons;

"WHEREAS, this august Body would like to consider also the City Mayor, the Vice-Mayor, the Councilors and the Secretaries to the Mayor and the Board for an increase in their respective representation allowances effective January 1, 1972, so that, with the tight financial condition of the city, we cannot as yet fully implement the memorandum circulars but partially insofar as the abovementioned department heads and other officials are concerned;

"WHEREAS, after consultation with the department heads concerned, it was agreed that the following will be the rates of increase of monthly representation allowances beginning January 1, 1972:

- 1. For the Mayor ₱100.00
- 2. For the Vice-Mayor 50.00
- 3. For the Councilors (8)..... 50.00 each
- 4. For the Secretary to the Mayor 50.00
- 5. For the Secretary to the Board 50.00
- 6. For the City Auditor 100.00
- 7. For the City Treasurer 100.00
- 8. For the City Assessor 100.00
- 9. For the City Fiscal 100.00
- 10. For the City Health Officer 100.00
- 11. For the City Engineer 50.00

so that a supplemental appropriation for this purpose will be necessary to cover the period up to the end of the current fiscal year as follows:

- 1. For the Mayor ₱ 600.00
- 2. For the Vice-Mayor 300.00
- 3. For the 8 Councilors @ ₱300.00 2,400.00
- 4. For the Secretary to the Mayor 300.00
- 5. For the Secretary to the Board 300.00
- 6. For the City Auditor 600.00
- 7. For the City Treasurer 600.00

8. For the City Assessor	₱ 600.00
9. For the City Fiscal	600.00
10. For the City Health Officer	600.00
11. For the City Engineer	300.00

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 18

AN ORDINANCE APPROPRIATING THE SUM OF SEVEN THOUSAND TWO HUNDRED PESOS (₱7,200.00) OUT OF FUNDS NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR ADDITIONAL REPRESENTATION ALLOWANCES OF CITY OFFICIALS IN PARTIAL IMPLEMENTATION OF MEMORANDUM CIRCULARS NO. 138, S.1967, AND NOS. 255 AND 270, S. 1970, OF THE OFFICE OF THE PRESIDENT.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of seven thousand two hundred pesos (₱7,200.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for additional representation allowances of city officials in partial implementation of Memorandum Circulars No. 138, series of 1967, and Nos. 255 and 270, series of 1970, of the Office of the President; at the rate of ₱100.00 per month each for the City Mayor, the City Auditor, the City Treasurer, the City Assessor, the City Fiscal and the City Health Officer, and at the rate of ₱50.00 per month each for the Vice-Mayor, the 8 Councilors, the Secretary to the Mayor, the Secretary to the Board, and the City Engineer.

SECTION 2. This Ordinance shall take effect on January 1, 1972.

ENACTED, December 22, 1971.
