RESOLUTION NO. 196

"WHEREAS, the Barrio Council of Barrio Cabulihan in its Resolution No. 4, current series, has requested this august Body to change the name of Cabulihan Community School to 'Teodoro Aviles Community School' in honor of the late Teodoro Aviles who was not only an upright judge of Ormoc City and an example of moral integrity in public service his life being unblemished, untarnished and free from corruption but also instrumental in the opening of the said community school and lent a helping hand always to the people of the community to the extent of donating a parcel of land which is now the barrio school site of Cabulihan;

"WHEREAS, this august Body finds the request of the Barrio Council of Barrio Cabulihan worthy of consideration to perpetuate the name of the donor of their barrio school site and that it is but fitting and proper that the community school be renamed in his honor and in memory of the man who has made possible the establishment of the said community school;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded jointly by Councilors Kangleon and Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 19

AN ORDINANCE RENAMING CABULIHAN COMMUNITY SCHOOL IN BARRIO CABULIHAN, ORMOC CITY, "TEODORO AVILES COMMUNITY SCHOOL".

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Cabulihan Community School in Barrio Cabulihan, Ormoc City, is hereby renamed "Teodoro Aviles Community School.


SECTION 2. This Ordinance shall take effect immediately upon its approval.




