"The Board, on motion of the Floor Leader, seconded jointly by Councilors Kangleon, Aviles and Samsen;

"RESOLVED, to adopt:

ORDINANCE NO. 2

AN ORDINANCE CREATING A NEW POSITION OF DRIVER IN THE HEALTH DEPARTMENT WITH COMPENSATION OF TWO THOUSAND ONE HUNDRED SIXTY PESOS (P2,160.00) PER ANNUM, PROVIDING FUNDS THEREOF, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. A new position of Driver is hereby created in the Health Department with compensation at the rate of two thousand one hundred sixty pesos (P2,160.00) per annum.

SECTION 2. The sum of nine hundred pesos (P900.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings in (C-25a) Agricultural and Veterinary Extension Services, said sum to be made available as supplemental appropriation for this purpose: Provided, That funds for the same shall be provided in subsequent general appropriations ordinance.

SECTION 3. This Ordinance shall take effect on the first day of February, 1971.
