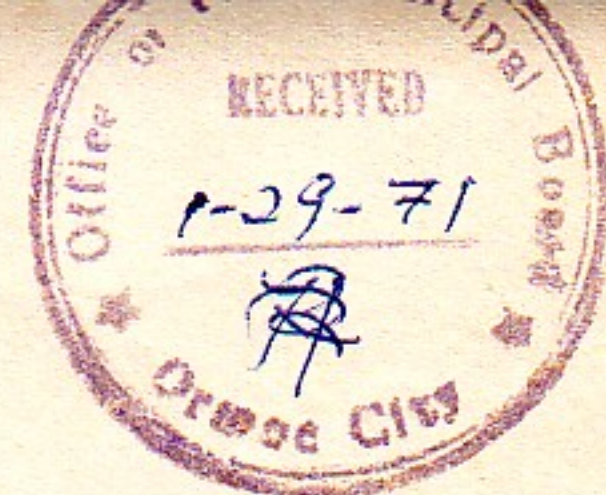
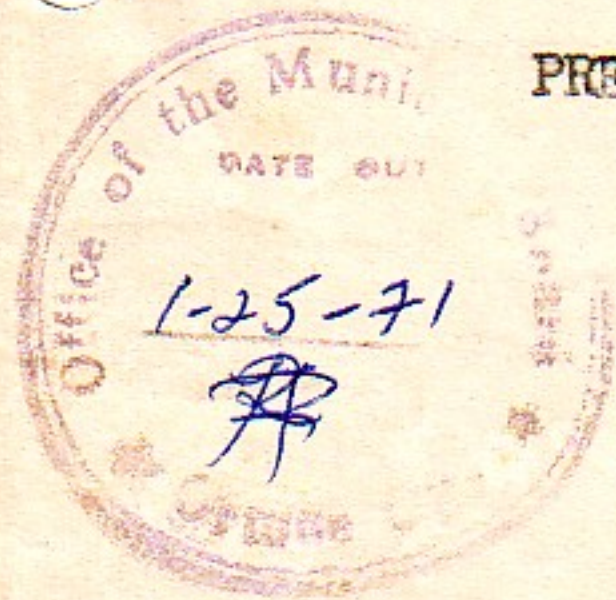

ORDINANCE NO. 3

AN ORDINANCE RESTORING THE ORIGINAL PROVISION FOR REPRESENTATION ALLOWANCE OF THE JUDGE OF THE COURT OF FIRST INSTANCE IN ITEM NO. 7 OF AIDS AND TRANSFER OF FUNDS, 1970-1971 CITY BUDGET, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Item No. 7 of Aids and Transfer of Funds, under Section 2 of Ordinance No. 48, series of 1970, otherwise known as the "1970-1971 Ormoc City Budget", is hereby restored to its original provision, to wit:

"7 : New Aid to Court of First Instance - for representation allowance of the Judge P1,200.00"

SECTION 2. Ordinance No. 75, series of 1970, is hereby repealed.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
