"RESOLVED, to adopt:

ORDINANCE NO. 62

AN ORDINANCE AMENDING FURTHER THE FIRST PARAGRAPH OF SECTION
1 OF ORDINANCE NO. 37, SERIES OF 1968, ENTITLED "AN ORDI-
NANCE AMENDING AND REVISING ALL ORDINANCES RELATIVE TO
FIXING AND REGULATING OF COLLECTION OF WHARF OR PIER
CHARGES IN THE USE OF PORT FACILITIES OF ORMOC CITY."

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The first paragraph of Section 1 of Ordinance
No. 37, series of 1968, entitled "An Ordinance Amending and Re-
vising All Ordinances Relative to Fixing and Regulating of Col-
lection of Wharf or Pier Charges in the Use of Port Facilities
of Ormoc City," is hereby amended further to read this wise:

"SECTION 1. Harbor, berthing, wharfage or anchorage
fee. - Every vessel propelled by steam or internal com-
bustion engine, excepting boats of less than five tons
gross or pleasure or non-commercial craft, which berths
at a pier, wharf, or which makes fast to any vessel at
such pier or wharf, anchors or moors at the Port of Or-
moc City for the purpose of loading or discharging cargo
or for any other purpose except when in distress, shall
pay a harbor, berthing, wharfage or anchorage fee, as
the case may be, as follows:

SECTION 2. This Ordinance shall take effect immediately
upon its approval.
