RESOLUTION NO. 93

"WHEREAS, due to inadvertence on the part of the Office of the City Judge to include in its budgetary proposal for the current fiscal year an outstanding obligation for vacation and sick leave accruing to Mr. Nelson DL. Geneston, former deputy clerk of court, this august Body failed to incorporate the same in the 1971-1972 Ormoc City Budget which prompted Mr. Geneston to make representations with this Board by means of a communication dated July 16, 1971, requesting an appropriation in the sum of six hundred sixty-five pesos and thirty eight centavos (P665.38), the money value of the balance of his accrued vacation and sick leave still to be collected by him;

"WHEREAS, it is the standing policy of the Sixth Municipal Board to settle obligations of this nature in three yearly installments whereby Mr. Geneston was able to collect the amount of three hundred thirty-two pesos and sixty-eight centavos (P332.68) representing one-third (1/3) of the total amount collectible as first partial payment and as provided for in the last fiscal year's city budget, so that this august Body would like that Mr. Geneston be paid the same sum as that of last year, P332.68, this time as second installment in the settlement of this outstanding obligation to him;

"NOW, THEREFORE, on motion of Councilor Samson, seconded jointly by Councilors Porcadilla and the Floor Leader;

RESOLVED, to adopt:

ORDINANCE NO. 7

AN ORDINANCE APPROPRIATING THE SUM OF THREE HUNDRED THIRTY-TWO PESOS AND SIXTY-EIGHT CENTAVOS (P332.68) OUT OF FUNDS EXISTING IN THE CITY TREASURY NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR SECOND PARTIAL PAYMENT OF OUTSTANDING OBLIGATION TO MR. NELSON DL. GENESTON, FORMER DEPUTY CLERK OF COURT FOR ACCRUED VACATION AND SICK LEAVE.

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. The sum of three hundred thirty-two and  
sixty-eight centavos (₱332.68), or so much thereof as  
may be necessary, is hereby appropriated out of funds  
existing in the City Treasurer not otherwise appropriat-  
ed, said sum to be made available as supplemental appro-  
priation for second partial payment of outstanding obli-  
gation to Mr. Nelson DL. Geneston, former deputy clerk  
of court, for accrued vacation and sick leave.

SECTION 2. This Ordinance shall take effect imme-  
diately upon its approval.
