

AT ITS SESSION HALL ON AUGUST 11, 1971



RESOLUTION NO. 101

"WHEREAS, the Assistant City Treasurer in a letter dated August 6, 1971, has requested a supplemental appropriation in the sum of three hundred sixty pesos (P360.00) for meal allowance of his office janitor in consideration of the latter's additional duties as city light inspector inasmuch as he failed to recommend this item in his budgetary proposal;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 8

AN ORDINANCE APPROPRIATING THE SUM OF THREE HUNDRED SIXTY PESOS (P360.00) OUT OF FUNDS NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR MEAL ALLOWANCE OF THE JANITOR OF THE CITY TREASURER'S OFFICE ACTING AS CITY LIGHT INSPECTOR.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of three hundred sixty pesos (P360.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for meal allowance of the Janitor of the City Treasurer's Office in consideration of his additional duties as city light inspector.

SECTION 2. This Ordinance shall take effect as of July 1, 1971.





"CARRIED UNANIMOUSLY."


