## RESOLUTION NO. 104

"WHEREAS, the Civil Engineer of the Bureau of Public Highways, this City, in his communication dated August 11, 1971, has, for and in the absence of the City Engineer, forwarded to this august Body a voucher in the amount of four hundred twenty-three pesos and forty centavos (P423.49) presented by the Codilla's Lumber for payment of the materials purchased for the construction of garbage boxes, which amount was originally absorbed in the pertinent budgetary outly of the City Engineer's Office for the last fiscal year but was reverted to the general fund at the end of said fiscal year upon failure of the creditor to present his claim as stipulated in the voucher;

"WHEREAS, the Civil Engineer has requested that this outstanding obligation of P423.40 be liquidated for the benefit of the supplier of the construction materials for garbage boxes;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by the Floor Leader;

"RESOLVED, to adopt:

## ORDINANCE NO. 9

AN ORDINANCE APPROPRIATING THE SUM OF FOUR HUNDRED TWENTY-THREE PESOS AND FORTY CENTAVOS (P423.40) OUT OF FUNDS NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR SETTLEMENT OF OUTSTANDING OBLIGATION TO THE CODILLA'S LUMBER FOR MATERIALS USED IN THE CONSTRUCTION OF GARBAGE BOXES.

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. The sum of four hundred twenty-three pesos and forty centavos (P423.40), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury; not otherwise appropriated, said sum to be made available as supplemental appropriation for settlement of outstanding obligation to the Codilla's Lumber for materials used in the construction of garbage boxes.

SECTION 2. This Ordinance shall take effect immediately upon its approval.






