RESOLUTION NO. 17

"WHEREAS, ever since the Ormoc Waterworks System had been retrieved from the National Waterworks and Sewerage Authority in favor of the Government of Ormoc City the said system has been operating as a separate and distinct office from either the city engineering or finance departments so that this august Body has contemplated to raise the category of the said office to a distinct department that will look after the needs of the city for this prime commodity;

"WHEREAS, the Ormoc Waterworks System has eleven employees headed by a Waterworks Supervisor whose rank this august Body would like to raise to Waterworks Superintendent with a higher compensation at the rate of ₱7,980.00 per annum, subject, however, to the approval of His Excellency, the President of the Philippines;

"WHEREAS, Section 17 of Republic Act No. 179, as amended by Republic Act No. 429, otherwise known as the Charter of Ormoc City, provides, among other things, that the Municipal Board may from time to time make such readjustment of the duties of the several departments as the public interest may demand, and, with the approval of the President, may consolidate any department, division or office of the city with any other department, division or office;

"NOW, THEREFORE, on motion of Councilor Mendola, seconded by Councilor Samson;

"RESOLVED, to adopt:

ORDINANCE NO. 1

AN ORDINANCE ELEVATING THE ORMOC WATERWORKS SYSTEM TO A DISTINCT DEPARTMENT OF THE CITY GOVERNMENT TO BE HEADED BY A WATERWORKS SUPERINTENDENT WITH COMPENSATION AT THE RATE OF SEVEN THOUSAND NINE HUNDRED EIGHTY PESOS (₱7,980.00) PER ANNUM, SUBJECT TO APPROVAL OF THE PRESIDENT OF THE PHILIPPINES.

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:



SECTION 1. The Ormoc Waterworks System is hereby elevated to a distinct department of the Government of Ormoc City such department to be headed by a Waterworks Superintendent with compensation at the rate of seven thousand nine hundred eighty pesos (P7,980.00) per annum.





"CARRIED UNANIMOUSLY."


