ORDINANCE NO. 10

AN ORDINANCE APPROPRIATING FUNDS FOR BUILDING AND LAND REN-
TALS OF THE AGRICULTURAL AND VETERINARY EXTENSION SER-
VICES AND MEAL ALLOWANCE OF THE JANITOR OF THE CITY
TREASURER'S OFFICE ACTING AS CITY LIGHT INSPECTOR.

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. The following sums, or so much thereof as
may be necessary, are hereby appropriated out of funds ex-
isting in the city treasury not otherwise appropriated to
be made available as supplemental appropriation for and in
the manner provided hereunder, to wit:

- (a) Building and land rentals of the Agri-
cultural and Veterinary Extension Ser-
vices at P200.00 per month P2,400.00
(b) Meal allowance of the Janitor of the
City Treasurer's Office acting as City
Light Inspector at P45.00 per month 540.00
Total P2,940.00

SECTION 2. This Ordinance shall take effect as of July
1, 1972.
