"RESOLVED, to adopt:

ORDINANCE NO. 11

AN ORDINANCE APPROPRIATING THE SUM OF ONE THOUSAND FIVE
HUNDRED PESOS (P1,500.00) FROM FUNDS NOT OTHERWISE
APPROPRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL
APPROPRIATION FOR THE MAYOR'S DISCRETIONARY FUND.

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. The sum of one thousand five hundred pesos
(P1,500.00), or so much thereof as may be necessary, is here-
by appropriated out of funds existing in the city treasury
not otherwise appropriated, said sum to be made available as
supplemental appropriation for the Mayor's discretionary fund.

SECTION 2. This Ordinance shall take effect immediately
upon its approval.
