RESOLUTION NO. 147

"WHEREAS, the Waterworks Superintendent in his communication dated October 25, 1972, to the Chairman of the Committee on Finance of this august Body has requested that Item No. 28 for office equipment under contingent expenses of the Waterworks System in the 1972-1973 Ormoc City Budget be increased by five hundred pesos (P500.00) which amount may be taken from out of Item No. 20 for repair of equipment and maintenance of motor vehicle and that said Item No. 28 be amended so as to read 'Office and plumbing equipment' in order that his office may be able to purchase the necessary plumbing tools;

That:

SECTION 1. Items numbered 20 and 28 under Contingent Expenses of (C-35) Waterworks System, 1972-1973 Ormoc City Budget, are hereby amended to read as follows:

"20 : 20 Repair of equipment and
maintenance of motor vehicle P3,500.00

28 : 27 Office and plumbing equipment 1,500.00"


SECTION 2. This Ordinance shall take effect immediately upon its approval.


