RESOLUTION NO. 149

"WHEREAS, Ex-Councilor Dionisio B. Torrevillas submitted for action by this august Body a voucher for reimbursement of actual representation expenses incurred during his incumbency for the period from July to December, 1971, in the sum of ₱1,790.00;

"NOW, THEREFORE, on motion of Councilor Samson, seconded jointly by Councilors Mendola and Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 15

AN ORDINANCE APPROPRIATING THE SUM OF ONE THOUSAND SEVEN HUNDRED NINETY PESOS (₱1,790.00) TO SETTLE OUTSTANDING OBLIGATIONS WITH EX-COUNCILOR DIONISIO B. TORREVILLAS FOR REPRESENTATION ALLOWANCES FOR JULY UP TO DECEMBER, 1971.

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. The sum of one thousand seven hundred ninety pesos (₱1,790.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, said sum to be made available as supplemental appropriation to settle outstanding obligations with Ex-Councilor Dionisio B. Torrevillas for representation allowances for July up to December, 1971.

SECTION 2. This Ordinance shall take effect immediately upon its approval.
