ORDINANCE NO. 15

SECTION 1. The sum of one thousand seven hundred ninety pesos (P1,790.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the City Treasury not otherwise appropriated, said sum to be made available as supplemental appropriation to settle outstanding obligations with Ex-Councilor Dionisio B. Torrevillas for representation allowances for July up to December, 1971.
