"WHEREAS, the Waterworks Superintendent and the Market Guards in their letters dated December 4 and 6, 1972, respectively, have requested amendment or modification of certain designations in their respective offices for the good of the service without necessarily affecting their rates of compensation;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 16

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 8, CURRENT SERIES, OTHERWISE KNOWN AS THE 1972-1973 ORMOC CITY BUDGET, SO AS TO MODIFY CERTAIN DESIGNATIONS ONLY UNDER (C-35) WATERWORKS SYSTEM AND (C-36) MARKET AND SLAUGHTERHOUSE.

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. Section 2 of Ordinance No. 8, current series, otherwise known as the 1972-1973 Ormoc City Budget, is hereby amended so as to modify certain designations only in the following offices:

(a) (C-35) Waterworks System

Item No. 6 - From "Guard-Chlorinating Attendant" to "Reservoir Caretaker"

Item No. 7 - From "Guard at Mahayag" to "Mahayag Watershed Caretaker"

Item No. 12- From "Watchman at Toon-Ahag Springs" to "Toon-Ahag Watershed Caretaker"

(b) (C-36) Market and Slaughterhouse

Item No. 5 - From "Market Guards" to "Market Laborers"

SECTION 2. This Ordinance shall take effect immediately upon its approval.






