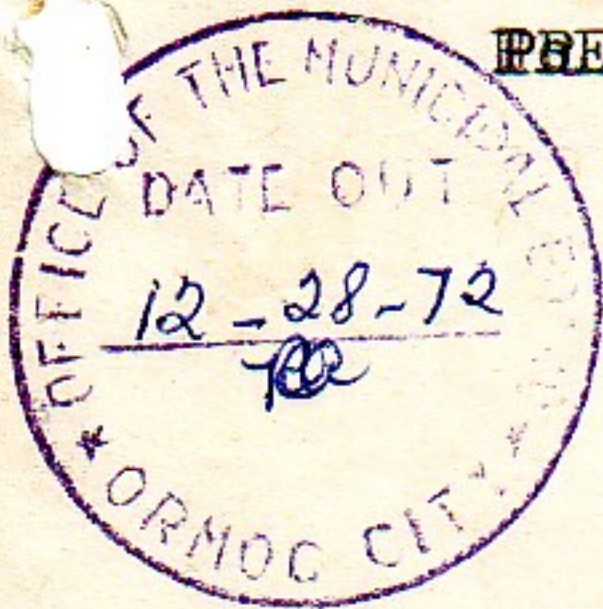


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE

AN ORDINANCE AMENDING ITEM NO. 21 OF (C-35) WATERWORKS  
SYSTEM UNDER SECTION 2 OF ORDINANCE NO. 8,  
CURRENT SERIES, OTHERWISE KNOWN AS THE  
1972-1973 ORMOC CITY BUDGET

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. Item No. 22 of (C-35) Waterworks System un-  
der Section 2 of Ordinance No. 8, current series, otherwise  
known as the 1972-1973 Ormoc City Budget, is hereby amended  
to read as follows:

"22 : 21 Travel, transportation and  
meal allowance ..... P1,200.00"

SECTION 2. This Ordinance shall take effect immediate-  
ly upon its approval.
