ORDINANCE NO. AN ORDINANCE AMENDING ORDINANCE NO. 18. SERIES OF 1971

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Title. - The title of Ordinance No. 18, series of 1971, is hereby amended to read as follows:

"AN ORDINANCE APPROPRIATING THE SUM OF SEVEN THOUSAND EIGHT HUNDRED PESOS \$7,800.00) OUT OF FUNDS NOT OTHERWISE APPROPRIATED TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR ADDITIONAL REP-RESENTATION ALLOWANCES OF CITY OFRICIALS IN PARTIAL IMPLEMENTATION OF MEMORANDUM CIRCULARS NO. 138, S. 1967, NO. 298, S. 1969, NOS. 255. AND 270, S. 1970, OF THE OFFICE OF THE PRESIDENT."

SECTION 2. Section 1 of Ordinance No. 18, series of 1971, is hereby amended to read as follows:

"SECTION 1. The sum of seven thousand eight hundred pesos (\$7,800.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for additional representation allowances of city officials in partial implementation of Memorandum Circulars No. 138, series of 1967, No. 298, series of 1969, Nos. 255 and 270, series of 1970, of the Office of the President, at the rate of one hundred pesos (\$100.00) a month each for the City Mayor, the City Auditor, the City Treasurer, the City Assessor, the City Fiscal, the City Health Officer and the City Development Officer, and at the rate of fifty pesos (₱50.00) each for the City Vice-Mayor, the eight

(8) City Councilors, the Secretary to the Mayor, the Secretary to the Board, and the City Engineer."

SECTION 3. This Ordinance shall take effect as of January 1, 1972.
