RESOLUTION NO. 46

"WHEREAS, the City Government has entered into a contract with Mrs. Felisa E. Samson for the use of a building and grounds by the Agricultural and Veterinary Extension Services with a monthly rental of two hundred pesos effective January 1, 1972, which calls for an appropriation of one thousand two hundred pesos (P1,200.00) to last up to the end of the current fiscal year;

"NOW, THEREFORE, on motion of Councilor Kangleon, seconded by Councilor Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 4

AN ORDINANCE APPROPRIATING THE SUM OF ONE THOUSAND TWO HUNDRED PESOS (P1,200.00) FOR BUILDING AND GROUND RENTALS OF THE AGRICULTURAL AND VETERINARY EXTENSION SERVICES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The sum of one thousand two hundred pesos (P1,200.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for building and ground rentals of the Agricultural and Veterinary Extension Services: Provided, however, That funds for this same purpose shall be provided for in subsequent appropriations until such time when the City shall have acquired a building and lot of its own to accommodate said office.


SECTION 2. This Ordinance shall take effect as of January 1, 1972.

ENACTED, March 9, 1972.






