"RESOLVED, to adopt:

ORDINANCE NO. 9 AN ORDINANCE AMENDING AIDS AND TRANSFER OF FUNDS, CAPITAL OUTLAYS, AND (J-27) STREET AND BRIDGE FUND, UNDER SECTION 2 OF ORDINANCE NO. 5, SERIES OF 1971, OTHERWISE KNOWN AS THE "1971-1972 ORMOC CITY BUDGET"

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Item No. 6 on the North diversion road construction under Capital Outlays is hereby deleted and, therefore, incorporated in Item No. 6 on Transfer to Street and Bridge Fund under Aids and Transfer of Funds and consequently reflected as a sub-item of the Transfer from City General Fund under (J-27) Street and Bridge Fund, so that these under Section 2 of Ordinance No. 5, series of 1971, otherwise known as the "1971-1972 Ormoc City Budget" as herein amended, including the corresponding totals, will now read as follows:

SECTION 2. This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FURTHER, to authorize the City Treasurer to adjust his accounts in this connection and, also, to avail of overcollections in some revenue items and/or revert the unexpended balances in various functional expense accounts and outlays in the general fund to offsett overdrafts in certain expense appropriations which were necessarily incurred in the interest of service, to support the closing entries in his account books at the end of the fiscal year;

"RESOLVED, FINALLY, to furnish a copy of this resolution each to the City Treasurer and the City Auditor, both of Ormoc City;
