"RESOLVED, to adopt:

ORDINANCE NO. 11

AN ORDINANCE TO RECREATE THE POSITION OF ASSISTANT CITY HEALTH OFFICER IN THE CITY HEALTH DEPARTMENT, PROVIDING FUNDS FOR COMPENSATION THEREOF AT THE RATE OF SEVEN THOUSAND EIGHT HUNDRED PESOS (P7,800.00) PER ANNUM, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. The Assistant City Health Officer. - The position of Assistant City Health Officer in the City Health Department is hereby recreated with compensation at the rate of seven thousand eight hundred pesos (P7,800.00) per annum.

SECTION 2. Appropriation. - For purposes of this Ordinance, the sum of seven thousand eight hundred pesos (P7,800), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated, said sum to be made available as supplemental appropriation for the salary of the Assistant City Health Officer.

SECTION 3. Effectivity. - This Ordinance shall take effect as of July 1, 1973.

ENACTED, November 15, 1973.
